Chapter Excellence Program applications for level 1 and 2, must be submitted in SkillsUSA Register (*register.skillsusa.org*) by March 6, and no extensions can be offered. We highly recommended submitted prior to the deadline date.

Do the technical standards change every year?

Do I have the most up to date technical standards?

Turn to the second page of any standard and look for the year at the bottom of the page. This should be the year members are competing. For this year, it should say "2022."

Will in-person competitions be part of State Qualifying Events?

Most of our community college partners are not ready to have guests back on their campus yet. We will be offering state qualifying events in February for students locally, online. We are exploring an option to add a more hands on component to this online offering beyond an exam for some career competitions. An example of this would using a program like Electude for Automotive Service Technology. We hope to restart regional competitions in 2023.

Section 6: State Officer Development Program

Do advisors have to travel with their state officers?

SkillsUSA Illinois does not require advisors to travel with their state offices. It is up to the local chapter (school) to decide if this is necessary. SkillsUSA Illinois does not provide transportation. Students are covered under SkillsUSA Illinois insurance at events.

What is the deadline to apply?

Applications must be submitted two weeks (14 days) prior to the first day of SLSC or *L.E.A.D.*

Why is there tiered pricing?

Members gain the greatest benefit of SkillsUSA is through intentionally integrated the SkillsUSA Framework into chapter activities. To incentivize this effort, SkillsUSA Illinois will offer discounted prices based on the CEP level achieved by the chapter.

Why shouldn't we drive to Atlanta?

Parking is very limited in the conference district of Atlanta. Standard vehicle parking is valet only at \$50-\$75 a day. Larger vehicle/ bus parking will be off-site at a higher rate.
